Strategic Development

This can mean a lot of things to a lot of people. 1421 is not a management consulting firm, so what it does not mean is anything to do with the internal affairs of a business. They assist foreign firms with their China strategy, so it's usually relating to how the firms operate in time and space throughout China. This is usually utilized (but not exclusively) by companies that are newer to China. Perhaps they are interested in how to bring their product or services to China, or if there is even a demand. 1421 could then create a feasibility study, or a market entry report to assist them in making and educated decision. For example, what the rules and regulations for importing non-standard products are, or what the demand is around certain high-end technological services.

Many foreign brands are interested in accessing the Chinese market, but do not want to create a Chinese entity, and therefor would like to find distributors to work with in China. This is another service or solution that 1421 offers.

Or, given their extensive history in China, 1421 also often offers general strategic planning for companies on how to access China, utilize China, build their brand, gain traction, etc.

Corporate Services

1421 also provides several corporate services to assist foreign companies with their more administrative challenges. One of the most popular among them is creating a WFOE, or Wholly Foreign Owned Enterprises. For a foreign company, this is often the most efficient way to operate and make profits in China.

Once a WOFE is created, it can be challenging to alter or change. 1421 also assists in changing a company's address, shareholders, corporate structure, legal representation and so on.

1421 also cancels WOFEs, which is usually more challenging than setting them up in the first place.

Local Bookkeeping and Tax Declaration

As stated, 1421 has an accountant team that will do the bookkeeping and tax declaration for companies operating in China. This is mandatory for all companies to stay compliant with the law. Any tax related project 1421 can either do in house or assist with.

Looking to the Future

1421's Shenzhen office has come a long way from its humble beginnings and is still expanding today. They are looking to assist companies all over the Greater Bay Area, and to assist foreign companies in taking advantage of the Free Trade Zones, Pilot Areas and "encouraged industries" that exist. 1421 Shenzhen is always willing to speak with people interested in China and opportunities that exist here.
